# Chairman Spear read the following:

Peter Britz described the work performed in the CES invoices. He said most of these invoices are split between OU-1 and OU-2 and the descriptions were already covered, except for Item C.

Peter Britz described the work performed in the CES invoices. He said the invoices are split between OU-1 and OU-2 except for Item H.

➤ Item H involved the pump test work plan, access agreement for the new well that is going in, owner correspondence to put the well in, review of MW-6 results from pump tests, and investigation scope.

Attorney Jaffe asked if the EPA needs to be called in for the access. Peter said NHDOT provided access on the culvert clearing and beaver work, this access being requested for installation of a new well. The DOT has been responsive to CES. The AG was going to come in and sign off on it this week, last we heard, he said. CES has been helpful in pushing that along.

Attorney Jaffe asked when we expect to do the expensive work. Peter said a new well is expected to be put in on November 25<sup>th</sup>. He did not think they would do packer sampling on the new well. After that they would do the pump test, CES can make that work even in the cold weather. It is a 96 hour pump test. The bills will follow a month or so later.

Attorney Seth Jaffe moved to approve items V – G-J for payment; Attorney Curtis Shipley seconded this motion.

# VII. COMBINED OU - 1 & OU - 2 ACTION ITEMS

# A. Report of Peter Britz of the City of Portsmouth dated 11/4/2020 with two attachments:

- CES Contract Amendment for surface water treatment and beaver mitigation, dated 10/23/2020 – Requires approval by CLG and signature.
- CES Contract amendment culvert blockage removal dated 10/2/2020 and signed by P. Britz on 10/21/2020. This is also Record Item VIII-B below

Peter summarized the activity report:

## Surface water treatment:

CES coordinated with the vendor. They came up with a pilot program. Peter said the filtration blankets would go in the next day.

Attorney Jaffe asked when we got agency approval to do this work. If there is no letter back, he asked Peter to send an email summarizing that we submitted the plan and we expect to be out in the field and implement on 11/5/2020 date.

Attorney Jaffe asked if the Feds said they would not approve the work, and Peter said the Feds did not say they were not going to approve.

Attorney Jaffe said they need to confirm the EPA's understanding and said this is a pilot test. EPA concurred this is work to be done under the consent decree, he added. Peter will make sure the work doesn't go ahead until EPA and NHDES concur with work.

Attorney Jaffe said if they agreed orally, we can document in writing. Otherwise, he would be leery of doing work without their approval.

Attorney Shipley said he has not seen anything in writing from DES. He agreed that they at least need an approval email. They can't do work under the decree without approval from EPA.

Attorney Shipley said the plan talked about getting three rounds of sampling done before cold weather sets in. Peter said it was uncertain that weather conditions would permit this.

Joe Montello asked if impact from the drought affects water sampling. Peter said all the water goes through one location. That water will come in contact with those blankets. That is a benefit of drought. He said the water level is still pretty low but he was not sure of drought status and will give updates.

# Deep bedrock study:

New well installation has been scheduled. Some work will still need to be done after the installation, which will not take too long – then they can do the pump test.

#### DOJ bill:

Peter stated we went from a six month to a full year invoice. We had to collect background data from CES. The amount of Invoice 12 will be \$97,078.62.

#### CES contracts:

- 1) CES Contract Amendment for surface water treatment and beaver mitigation, dated 10/23/2020 Required approval by CLG and signature.
- 2) CES Contract amendment culvert blockage removal dated 10/2/2020 and signed by P. Britz on 10/21/2020. (*This is also Record Item VIII-B below*).

Peter said a signature was needed for Item 1. According to the wildlife biologist, beavers sometimes leave and then come back, he said. Attorney Jaffe said if they don't do anything, we don't pay anything – we pay only for services provided.

Attorney Seth Jaffe moved to authorize Chair Spear to sign the contract extension; Attorney Curtis Shipley seconded this motion.

On a roll call 3-0 vote, the Committee approved this motion.

Peter said the second contract related to backhoes needed to remove blockage.

# B. Update on meetings with two CPA firms:

- Leslie Walker of Mason & Rich, PA
- Frank Saglio of Wipfli LLP

Attorney Sullivan had asked what work the firms do. He said he preferred the Wipfli firm.

In referencing the email chain (re: Coakley / Trusts & Taxes) from 10/27 and 10/28/2020, Attorney Shipley said assuming Wipfli's analysis was correct, we have two trusts that we are treating differently for tax purposes, and he does not know why they are being treated differently. If one is correctly being treated as a QSF, are there additional administrative expenses that should be deducted? If so, we should not ever have a tax payment.

Attorney Jaffe asked if it is legitimate to treat both differently – one being a QSF and the other being only a grantor trust. He asked if we can deduct Peter's services, and would that mean we would not pay any taxes. He would like to know if what we have been doing is legitimate and he would pay money upfront to have an accounting firm advise the Group on this. If there is flexibility in tax treatment of the trusts, then keep the status quo, he said. But if we can't deduct the expenses for Peter's services, then he would change the status so we don't pay taxes. Attorney Shipley agreed.

Attorney Sullivan said we should start with the accountant we have right now and ask if they can answer the question.

Marian will contact the existing CPA firm and ask if they can answer this question: "Based on the terms of the Participation Agreements and Trust Agreements for OU-1 and OU-2, is it legitimate to treat one trust as a QSF and one as not."

Attorney Jaffe said they are both grantor trusts. He believes OU-1 is being treated as the QSF. They are being taxed under different sections of the tax code. What kind of trusts are they really, and how (and can) must they be treated? If we don't have to pay taxes in the future, we want to be able to avoid that, he added.
