Islington Creek Neighborhood Pushes Back

- Islington Creek (IC)residents have complained to Pan Am for years and brought the issue to the City Council.
 - Not much was accomplished federal rail laws supersede!
- Surface Transportation Board Docket No. FD 36472 on the merger of CSX with Pan Am and numerous small rail companies
 - 4 Islington IC residents filed 2 public comments and one testified at a zoom hearing in January 2022
 - CSX president promised action and the STB chair assured positive action
 - **O ALL WITHOUT SUCCESS**
- 6 IC residents filed a formal complaint letter on October 29, 2023


A note about the filing process

Frequency of Incidents

Monday, 10/23/23 - Early morning idling for 2+ hours with two engines next to the Rock Street playground. The crew was nowhere to be seen. "Called the CSX Ops line politely about the 2-3 hours of the two engines at the playground idling at that moment. Ops person replied brusquely." "They're very often extremely annoyed, as if we bother them with this when they're working. Yet that is the line we're supposed to call."

Friday, 10/20/23 - 4-5 hours of idling at night, dinner time onwards.

Monday, 10/16/23 - Train arrived at 5:10 AM and has been idling for over 4+hours.

Tuesday, 10/10/23 - Early AM around 7am until noon - idling, waiting for crew.

Friday, 9/1/23 - AM the train was idling for hours, which occurred many times throughout this week.

Tuesday, 8/22/23 - 7:10AM the train sat at the Foundry Garage for nearly two hours idling/billowing diesel smoke requiring residents to close windows.

Monday, 8/21/23 – The train returned at 1:49 AM with the switching and horns, then again at 4:40 AM. The train returned at 7:30 AM to idle for 2 hours before it left to service customers.

And many more.

No change in operations in spite of numerous interactions

Planned Next Steps

- Wait for the STB to reply
 - STB has a full agenda (5-6 open dockets, dozens of filed comments since October 29th)
 - Formal letter or contact by CSX possible
- Direct contact to STB by Senator Shaheen or Congressman Pappas after yearend – "Why have you not replied yet?"
- Seek a formal meeting with CSX via intervention from Senator Shaheen's office
